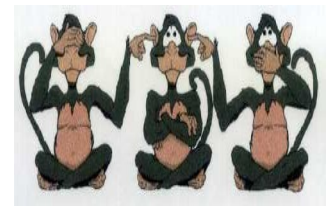

That is all I have for now. We will be recapping the Feast at the October 15th meeting. If you haven't made a meeting this year please try and attend. The meetings have been fun and informative.

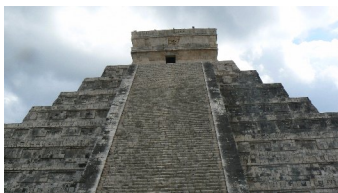
